Commentary

Norte Long Only ended March with a negative performance of 1.55%, compared to -2.91% for the Ibovespa. For the second consecutive month of losses in the local stock market, positive highlights included stocks in the healthcare came also from sanitation, airlines, education, and electricity sectors. Negative highlights were stocks related to petroleum, discretionary consumer goods, food and beverages, and financials. The offshore equity portfolio showed a slightly negative return. Year to date, the fund has accumulated a negative return of 2.06%, compared to -7.16% for its benchmark, the Ibovespa.
